# ENVIRONMENTAL JUSTICE WORK WITH CHILDCARES A GREAT SUCCESS

Midwest Pesticide Action Center's Pesticide-Free Childcares: Environmental Justice for Children project has seen great success in 2014. Funded by the U.S. EPA and our spring crowdfunder, the goal was to increase the number of licensed



childcare facilities that are complying with the Illinois Structural Pest Control Law, which has been on the books since 2004. Midwest Pesticide Action Center has worked with the Illinois Department of Public Health and University of Illinois Extension Services to educate childcare providers on the requirements of the law and move them toward compliance. Now, at the end of 2014, 92% of licensed childcares are compliant, up from 56% at the beginning of the year. As a companion to these efforts, Midwest Pesticide Action Center worked with the Illinois Child Care Reference and Referral Agency (INCCRRA) to develop an online training tool for childcare staff to learn about integrated pest management (IPM) and receive continuing education credits upon completion. Scheduled to be available online by the time you receive this Update, we will follow the use of the training closely and report back on its success.

This project will provide a baseline of data to work from and an easily accessible education tool, making it possible for Midwest Pesticide Action Center and partners to work towards full implementation of IPM in childcares and improving the environmental conditions for all children being cared for in licensed facilities.

### **LEGISLATIVE WATCH: NEWS & UPDATES**

Enlist Duo - Despite massive opposition, the U.S. EPA has approved Dow Chemical Co's Enlist Duo for use on GMO crops. Enlist Duo is a toxic combination of herbicide 2.4-D and glyphosate that has been linked to Parkinson's Disease and other serious health conditions. There is still time to take action - Midwest Pesticide Action Center will continue to work with like-minded orgs to stop this latest escalation.

Illinois Pesticide Act - SB 3565, an addendum to the Illinois Pesticide Act, would allow any community within Cook County with over 50,000 residents to regulate their own pesticide usage. It has been moved to the Senate Agriculture and Conservation Committee. While progress on passing Senator Harmon's bill is still possible, we do not anticipate an easy or quick campaign forward. Earlier this year, the French parliament passed a bill banning the use of pesticides in all parks and public spaces by the year 2020 and drastically limiting the use of pesticides in homes and gardens. #### **OUR OUTDOOR PROGRAM EXPANDS**

Great progress has been made over the last few months to advance our outdoors programs. We are currently working with five communities to move their park districts to more sustainable lawn care and landscaping practices through our A Healthy Park is a Natural Park campaign. Our Chicago Grows Green campaign designed to move retailers to stock more products and educational materials promoting sustainable turf care, has been rebranded to Midwest Grows Green and expanded beyond the Chicago borders. We currently have 30 retailers participating, many in the Illinois Coastal Zone where runoff impacts Lake Michigan. And, we worked with Oak Park and River Forest through a Manaaki

Foundation grant to develop a campaign for better communication on mosquito spraying which can be packaged as a model template for coordinated activities in other communities. A lot of hard work has gone into developing these campaigns and we are hoping to be able to expand them in 2015, with continued support from our donors.
